Physical activity and sport for all is a fundamental right of every human being; and sport can be an effective tool for integration of refugees in their host communities.

In 2021, ISCA awarded organisations and individuals who have delivered good practices in Integration of Refugees Through Sport (IRTS) in four categories IRTS Role Model (citizens' choice); IRTS cross-sector partnership; IRTS innovation during Covid-19 and Integration of women and girl refugees through sport. This year we want to awards the good practices in the following four categories:

IRTS & Community
IRTS & Mental Health
Refugee-led initiatives

2. Why apply?

Gain visibility and recognition for your achievements, and win a trip to Copenhagen

 All eligible applicants will have their initiatives listed on the ISCA Awards webpage.





- All shortlisted finalists (3 from each award category) will have a description of their initiative on the webpage.
- All shortlisted finalists will receive support from ISCA in their PR efforts to promote their awards and nominations.
- All shortlisted finalists will be awarded a trip to Copenhagen, Denmark to showcase their work on the global stage, and be announced as winners at ISCA's <u>MOVE Congress 2025</u> 29-31 October 2025 (with flight, hotel and fee covered*).

Win a cash prize

The winner from each category will receive a cash prize of 3000 euro

Professional development opportunity

During MOVE Congress you get inspired by following different panel discussions, listening encaging Keynote speakers and attend at various workshops. Attending MOVE Congress will give you a unique opportunity for high quality networking.

This is a call for applications from organisations and individuals that have delivered good practices in IRTS activities. We have designed a novel application process that makes it easy for you to apply and enables you to focus on your strengths.

Our jury will select three shortlisted candidates in each of the four categories. In the Role Model award, the winner among the shortlisted candidates will be found through online citizen voting. In the other three categories, the jury will select the final winner.

3. How many awards are on offer?

ISCA Awards 2025 will be presented in four categories in 2025:

• IRTS Role model (citizens' choice)

This category shines a spotlight on individuals whose inspiring leadership and dedication have created meaningful change in the world of inclusion through sport and recreation. These role models demonstrate the power of one person's vision to uplift communities and make a lasting impact on those who need it most.

IRTS & Community

Celebrating initiatives that bring people together, this category honours projects that use sports and physical activity to strengthen bonds, foster

belonging, and create inclusive spaces where everyone feels valued. It's about the heart of community – collaboration, compassion, and shared joy.

• IRTS & Mental Health

This category recognizes programs that use sports and physical activity to support mental well-being, build resilience, and empower participants to thrive. These initiatives emphasize the vital role of movement in fostering balanced and healthier lives.

• Refugee-led initiatives

This category celebrates the courage and creativity of refugees who lead initiatives to rebuild lives and foster inclusion through sport. Their work demonstrates resilience and the ability to create new opportunities for themselves and their communities, proving that sport is a universal language of hope and connection.

4. Eligibility and award criteria

Eligibility criteria

To be eligible for evaluation by the jury, the applicants must fulfil the following criteria:

- Applications are open to organisations, individuals and institutions worldwide. They can be from the local, national or international level.
- Any entity or individual may apply from NGOs, public sector, private sector, education etc.
- The application must be submitted in English with the completed data required, by the stated deadline. You can use e.g. <u>Google Translate</u> if needed.

Assessment questions

If an applicant has fulfilled the eligibility criteria, the jury will assess the applications. An application must showcase a good practice in one of the four award categories. An applicant can apply in more than one category but can only be shortlisted for one award. In the application form, we invite the applicants to touch upon the following questions:

- Who are you/your organisation?
- What do you want to achieve?
- What is the approach/work/activities you deliver?
- How are refugees and the local community involved in the design and implementation of activities?
- Who are your partners?
- What barriers have you overcome?



- What makes your work unique?
- What is the impact you have made?
- How do you ensure visibility and awareness to your project?

For the Role Model category, the nominating person will answer the questions on behalf of the nominee. It is also allowed to nominate yourself.

- Describe the outstanding work and achievements of the nominee in IRTS.
- How has the nominee made a significant impact on the lives of others through their initiatives or activities?
- What makes the nominee's work unique and deserving of recognition?
- How has the nominee demonstrated leadership, dedication, and innovation in the field of IRTS?

We have created a novel process for applying and evaluating submissions. This means that applicants can describe their work in their own way and focus on their strengths. Applicants decide how much information they deem necessary to have their work assessed, and they can provide links to pictures, videos and websites.

5. Application and selection process

- 1. **Application Form**. Please complete your application by using this form and submit it no later than **25 June 2025**. The number of characters for the summary is maximum 800 characters and the full description cannot exceed 5000 characters. But consider if you can make a concise and compelling description in less! You may provide up to 5 links to relevant videos, pictures and websites. Consider how you can best persuade the jury and make use of your existing materials.
- 2. **Notification from ISCA.** You will receive a confirmation e-mail when your application is submitted, and you will be notified of the results of the application and selection process.

4. Selection:

- All eligible applications will be assessed by the jury and 3 shortlisted applications per category will be announced on 15 September 2025.
- b. The jury will select 3 winners (1 per category except for the Role Model category) and announce them at the award show on **29 October 2025 in Copenhagen.**



c. **The people's choice award** voting will start among all shortlisted applications online on **15 September 2025** and will run until **15 October 2025**. The winner will also be announced on **29 October 2025**.

5. Awards ceremony:

All 12 shortlisted candidates be invited to the ISCA Global IRTS Awards 2025 celebration in Copenhagen on **29 October 2025.** They will have their flight*, accommodation and event participation at the MOVE Congress 2025 covered by ISCA.

6. Evaluation process

- ISCA's secretariat will assess the eligibility of the applications based on the eligibility criteria outlined above.
- A jury will evaluate the remaining applications. They evaluate based on their expertise and the provided information and score each application. Final winners are selected after jury deliberations.
- The "Citizens Choice" voting online will determine the winner among the shortlisted candidates in the Role Model category.
